The Year in Review

2011 proved to be a high impact year for FUND Consulting. We served 59 clients in 21 states. These 59 clients consisted of 29 CDFI Banks and Credit Unions, 23 Loan Funds, 6 Native Loan Funds, and 1 municipality. These organizations represent \$10,422,684,751 in assets, and have portfolios outstanding totaling \$6,216,730,140.



FUND Consulting works in partnership with its clients to provide both strategic and operational services designed to help clients articulate and achieve their goals. In 2011, FUND Consulting completed 27 customized strategic projects including market studies, capitalization plans, strategic plans, and impact analyses.

Additionally, the FUND team delivered 52 operational projects including CDFI Certification applications, funding applications to the CDFI Fund, and a successful NEXT Award application. As a result, applications prepared by FUND Consulting generated \$41,802,671 in grants, investments, and tax credits for clients during 2011:

Client Spotlight: Access to Capital for Entrepreneurs (ACE)

Founded in 2000 and certified as a CDFI in 2004, Access to Capital for Entrepreneurs (ACE) is a nonprofit loan fund located in Cleveland, Georgia. Over the years the organization has continually taken strategic steps to increase its capital base and products in response to demand and gaps in access in its largely rural target market.

In 2010, FUND Consulting joined ACE in its strategic endeavors, resulting in significantly increased capacity for the organization. ACE first engaged FUND Consulting to complete two funding applications which resulted in \$1.1 million in additional capital for the organization and the creation of its George Green Loans Fresh Food Financing initiative. This initiative aims to encourage supermarket and grocery store development in low- and moderate-income communities in metro-Atlanta.

Since then, ACE has engaged FUND Consulting on an annual basis to assist with funding applications, compliance, and strategic research services. As a result, ACE was named as one of the Small Business Administration's newest lenders through its Community Advantage pilot program, which aims to expand access to capital in underserved communities, and has a FA application for additional capital pending with the CDFI Fund. Currently, FUND Consulting is conducting research on a potential new capital raising model which will help ACE diversify and increase its capital base to continue providing much needed small business financing in North Georgia.

ACE provides lending capital and corresponding financial education, including microloans, Georgia Green Loans and Fresh Foods financing, energy efficiency loans, and commercial loans throughout a 68-county service area in North Georgia. With a focus on low-to-moderate income, women, and minority businesses, ACE has provided more than \$7 million in financing to date, which has resulted in the creation or retention of over 1,000 jobs. FUND Consulting looks forward to continuing its partnership in support of ACE's successes.
